Darebin City Council is committed to sustainable waste management and encourages the community to reduce the amount of waste produced in households.

The green waste bin is now a food and green waste bin. Food and green waste recycling is an optional service for residents. Charges for this service are billed to the ratepayer through the rates notices. Only the ratepayer for the property can request an optional food and green waste recycling service. Discounts are available to pension card holders.

If you are a tenant in a rental property and would like this service, you will need to contact the property owner or agent and request that they order the food and green waste recycling service on your behalf. Property managers will require a letter of support from the property owner.

- Council reserves the right to carry out an audit of your waste bin.
- Use of a food and green waste recycling bin will be withdrawn if inappropriate items are placed in the bin.
- Refunds will not be given for food and green waste recycling bins once the bin is delivered.
- Council reserves the right to review its policy and Conditions of Use at any time and apply changes as required.
- Council reserves the right to remove a food and green waste recycling bin if:
  - it is used for any reason other than for household waste as described above; and/or
  - any of the conditions outlined in this application are breached; and/or
  - the information you have provided on this form is found to be untrue
