

Terms and Conditions: Environmental Film Festival ticket giveaway

General

1. The Promoter is Darebin City Council (“Darebin”) (ABN 75 815 980 522) of 274 Gower Street, Preston Victoria 3072.

3. Information on how to enter and prizes forms part of the terms of entry. Entry into the competition is deemed acceptance of these terms and conditions.
4. If there is any inconsistency between these Terms and Conditions and anything else that refers to this competition, these Terms and Conditions will prevail.

Who can enter

5. Entry is open to anyone who lives, works or studies in Darebin, with the exception of employees of the Promoter. Immediate families of employees are eligible to enter.

When to enter

6. The competition commences on Monday 21 October, 2019 at 12pm AEST and concludes on Thursday 24 October at 5pm. AEST. Entries must be received by the Promoter prior to the competition close date and time.
7. The time of entry will in each case be the online entry received by the Promoter’s database, not at the time of transmission by the entrant.
8. The Promoter accepts no responsibility for any late, lost or misdirected entries

How to enter

9. To enter via Facebook entrants must:
 - a. Access and log in to their personal account
 - b. Like the original competition post
 - c. Tag a friend in the comments
