PROPOSED ROAD DISCONTINUANCE

The Darebin City Council, acting under section 206 and Schedule 10 Clause 3 of the *Local Government Act 1989* ("the Act"), proposes to discontinue the road adjoining 203 and 205 Dundas Street, 5 and 9 Toolangi Grove and 2 and 4 Adams Street, Preston, which is shown hatched on the plan below.

If discontinued, Council proposes to sell the land from the road by private treaty to the adjoining property owners and to transfer to itself any land that remains unsold.

Any person wishing to make a submission on the proposal must do so in writing to the undersigned no later than **Friday 27 November 2020**.

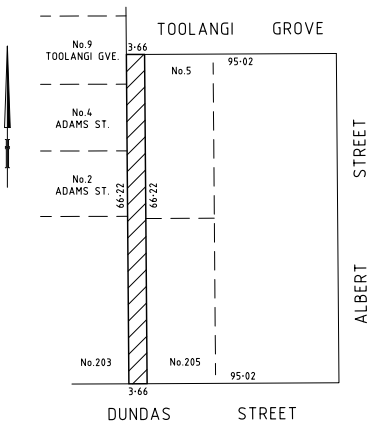
A person making a submission is entitled to request in the submission that they wish to appear in person, or to be represented by a person specified in the submission, in support of the submission at a meeting of the Council or its Committee on a date, time and place to be determined by the Council.

All submissions will be considered in accordance with section 223 of the Act.

Following the consideration of any submissions, Council may decide to discontinue and sell the road, part of the road, or not to discontinue and sell the road. Further Council may also decide whether or not to transfer to itself any land remaining unsold if the road or part thereof is discontinued.

Any person making a written submission under section 223 of the Act is advised that all submissions and personal information in the submission will be handled by Council in accordance with the provisions of the *Privacy and Data Protection Act 2014*.
