#### 4.1 COUNCILLOR CONDUCT OFFICER

#### **EXECUTIVE SUMMARY**

On 26 September 2022, Council resolved to note the extension of the appointment of Megan Lawton, Council's Councillor Conduct Officer.

In accordance with section 150 of the *Local Government Act 2020*, this report seeks to further extend the existing appointment for a period of three (3) months.

#### Officer Recommendation

#### That Council:

(1) Extend the appointment of Megan Lawton as the Councillor Conduct Officer until 28 April 2023, or earlier by agreement, to ensure continuity in the handling of Councillor conduct matters.

#### **BACKGROUND / KEY INFORMATION**

At its meeting of 26 September 2022, Council noted the extension to the appointment of Megan Lawton until 18 January 2023. The September 2022 extension followed the original appointment via a Council resolution dated 18 July 2022.

Section 150 (2)(b) of the *Local Government Act 2020* requires the following:

#### **Appointment of Councillor Conduct Officer**

- 1) The Chief Executive Officer must
  - a) Appoint a person in writing to be the Councillor Conduct Officer; and
  - b) Notify the Principal Councillor Conduct Registrar of the appointment.
- 2) Subject to subsection (3), a person may be appointed to be a Councillor Conduct Officer if
  - a) The person is a member of Council staff; or
  - b) The Council resolves that the person is suitably qualified to perform the functions of the Councillor Conduct Officer.
- 3) The Chief Executive Officer cannot be appointed as a Councillor Conduct Officer.

#### **Previous Council Resolution**

At its meeting held on 18 July 2022, Council resolved:

'That Council:

- (1) Confirm the qualifications and experience contained in the resume provided in **Appendix A** demonstrates the proposed Councillor Conduct Officer is suitably qualified to perform the functions of the Councillor Conduct Officer.
- (2) Appoint **Megan Lawton** as the Councillor Conduct Officer effective from 19 July 2022.
- (3) Note the appointment of the Councillor Conduct Officer is made with an exemption from the Social and Sustainable Procurement Policy due to urgency and the sensitive nature of requirements and matters in hand.
- (4) Directs and authorises the CEO (or delegate) to do all things necessary to appoint **Megan Lawton** as Councillor Conduct Officer'

At its meeting held on 26 September 2022, Council resolved:

#### 'That Council:

(1)-(9) ...

(10) Notes that the appointment of Megan Lawton, Councillor Conduct Officer made on 19 July 2022 will remain in place until 18 January 2023, or earlier by agreement, to ensure continuity in the handling of Councillor conduct matters.'

#### **ALIGNMENT TO 2021-25 COUNCIL PLAN**

Strategic Direction 4 Responsible, Transparent and Responsive

#### **DISCUSSION**

To best provide continuity in this function for the next three months, it is recommended that Megan Lawton continue as Council's Councillor Conduct Officer.

The transition of these responsibilities to the officer position planned for, under delegation of the CEO is no longer possible at this time.

#### **CONSIDERATION OF LOCAL GOVERNMENT ACT (2020) PRINCIPLES**

#### Financial Management

The existing Governance Department budget has sufficient funds to cover the cost of the proposed extension.

#### **Community Engagement**

No community engagement has been undertaken. This is a legislative function that Council is required to provide.

#### Other Principles for consideration

#### **Overarching Governance Principles and Supporting Principles**

(a) Council decisions are to be made and actions taken in accordance with the relevant law;

#### **Public Transparency Principles**

(a) Council decision making processes must be transparent except when the Council is dealing with information that is confidential by virtue of this Act or any other Act;

#### **COUNCIL POLICY CONSIDERATIONS**

#### **Environmental Sustainability Considerations (including Climate Emergency)**

This proposal does not have environmental sustainability considerations or impacts.

#### Equity, Inclusion, Wellbeing and Human Rights Considerations:

The function of the Councillor Conduct officer is important for good governance and the functioning of equitable, inclusive local government as an important democratic institution.

#### **Economic Development and Cultural Considerations**

This proposed extension does not have Economic Development or Cultural considerations or impacts.

#### **Operational Impacts**

This decision is recommended to ensure that the function can be effectively delivered to support Councillors with existing conduct matters and to ensure compliance with section 151 of the *Local Government Act 2020*.

#### Legal and Risk Implications

Section 150 of the *Local Government Act 2020* requires the CEO to appoint a Councillor Conduct Officer. A person may be appointed to be a Councillor Conduct Officer if the person is a member of staff or the Council resolves that the person is suitably qualified to perform the functions of the Councillor Conduct Officer. The function of the Councillor Conduct Officer is set out in section 151 of the *Act* and includes responsibility for assisting the Council to implement and conduct its Council's internal arbitration processes.

#### **IMPLEMENTATION ACTIONS**

Confirm the three (3) month extension from 19 January 2023 in writing

This document and supporting appendices have been designated as confidential by the Chief Executive Officer, in accordance with Section 3 (1) of the Local Government Act 2020, as private commercial information, being information provided by a business, commercial or financial undertaking that if released, would unreasonably expose the business, commercial or financial undertaking to disadvantage.


