STATEMENT FROM THE MAYOR ABOUT THE TRAGEDY IN KOCANI

The Chairperson, Mayor Olaris OAM, opened the meeting with the following statement:

I would like to express Darebin Council's deepest condolences to the Macedonian Community following the devastating nightclub fire in Kocani.

This recent tragic incident took the lives of at least 59 people and left nearly 200 others injured, most of whom are young people. It has deeply shaken the community—both in Kocani and here in Darebin. The grief is especially heavy as so many young lives were cut short.

Darebin is home to a large and close-knit Macedonian community, and Cr Boglis and I have had many residents reach out who are deeply hurting.

On behalf of the Darebin Council, I want to acknowledge the profound impact and far-reaching nature of this tragedy, including here in Darebin, and let you know that we share your pain.

I would also like to thank the Victorian government for lighting up Federation Square and the NGV in Macedonian red and yellow, and Nathan Lambert, member for Reservoir and Preston who acknowledged the tragic incident in Parliament.

Our thoughts are with the Macedonian community at this incredibly sad and difficult time. In times of sorrow, it's so important that we stand together in support and solidarity

6. COUNCIL'S OCCUPATIONAL HEALTH AND SAFETY RESPONSIBILITIES

The Chairperson, Mayor Olaris, made the following statement:

Council has an occupational health and safety responsibility to ensure anyone attending tonight's meeting, feels safe both physical and emotionally.

It's great to see everyone here this evening. I would like to remind everyone in attendance to be respectful of each other, and as outlined in our Governance Rules, please note the following:

7. QUESTION AND SUBMISSION TIME

Responses were provided to the following questions submitted for Public Question Time.

- **Sandra Li**

Is Council aware of the results from the recent Amplify study on housing reform, where 94% of respondents were shown to approve of upzoning?

Does Council intend to act with greater conviction and urgency on this and similar studies, which show both that the majority of residents are in favor of increasing housing density, housing availability, and public transport access, and that increasing housing density and reducing sprawl would overwhelmingly be a net positive for the city and the majority of its residents?

Response From General Manager Customer & Corporate

Thank you for the questions, Sandra. I wasn't aware of the Amplify Study, thank you for sharing it. Last year Council consulted the community on its Draft Darebin Housing Strategy. Housing continues to be a priority for Council through its own planning work and through advocacy.

Council's draft Housing Strategy aims to increase housing growth and diversity in the most accessible parts of the municipality close to existing services, facilities, and public transport. Amongst other things, the strategy recommends upzoning land in these locations to increase residential densities in existing urban areas.

• **Barbara Trauer**

I have a question about agenda item 9.5 'Submission to the parliamentary inquiry into the redevelopment of Public Housing'

Darebin Council's proposition for 'more public housing' does not challenge the government's demolition policy which is environmentally and economically unsound.

Will Darebin Council express opposition to the demolition of the Holmes Street public housing tower unless there is an independent and cost-quantified structural, engineering and architectural assessment of the suitability of the Holmes Street tower for retrofitting refurbishment of the building - coupled with an additional infill of new dwellings?

Response From General Manager Customer & Corporate

Thank you for your question, Barbara. This is a topic that will be considered by Council tonight.

• **Nicole Brown**

1. Can the feasibility study for Edwardes Street, Henty Street, and Gilbert Road be expedited, given ongoing concerns about pedestrian safety and heavy traffic in the area?
2. Will the study aim to address resident concerns regarding the lack of safe pedestrian crossing options near Edwardes Lake and JE Moore Park, as well as traffic management updates - including the removal of the Henty St/Gilbert Rd roundabout, speed reductions, and/or the installation of speed bumps on Henty Street?
3. Could you clarify how proposed pedestrian safety measures, like walk crossings or traffic lights, might impact traffic flow, and what alternatives are being considered to balance pedestrian safety with traffic efficiency? Residents are particularly concerned that child and family safety is being compromised for the sake of maintaining driver convenience in an area with high pedestrian traffic

Response From General Manager Customer & Corporate

Thank you for your questions, Nicole.

1. Council will consider its draft capital works budget for 2025/26 in April. community can make a submission during May.
2. The type and location of road safety improvements is typically done through Council's Your Street, Your Say program. The Gilbert/Henty Street roundabout has been identified for improvements. There is currently no endorsed project to install speed humps along Henty Street.
3. Council is working to improve safety for everyone. This is being achieved by introducing safer speeds and making changes on the road where people are crossing.

A number of questions were received about issues at Edwardes Lake Park, including fishing and electric bikes. In line with our Governance Rules, the first person to submit the 'like question' was permitted to ask their question, with all other like questions grouped together and an overall response provided.

- **Natali Barnett**

I would like to know what the council plans to do about illegal fishing at Edwardes Lake, as I personally have seen the devastating consequences it is having on the wildlife.

Response From General Manager Customer & Corporate

Council officers routinely patrol Edwardes Lake Park both inside and outside of business hours to ensure compliance with the Local Law and Domestic Animals Act 1994. There are signs which prohibit fishing Edwardes Lake Park, but we know from feedback that the signage related to fishing and motorised vehicles is inadequate. Council is working on this. A small number of infringements have been issued in Edwardes Lake Park in the last 12 months. Officers prefer to educate park visitors.

Tonight, Council is considering a draft Local Law to go out for public exhibition. If adopted, fishing will be explicitly prohibited and Council will have more tools to enforce the Local Laws. Council will support the new Local Law with a community education campaign.

- **David Taylor**

1. The Local Government Act at section 110 refers to Councils being able to become a member of a corporation such as DCMC and make payment of subscription fees. At its Rule 11 and elsewhere, DCMC is allowed to apply membership subscription fees. This derives from Schedule 1 of the Associations Incorporation Reform Act 2012.

In the view of Council, would the levying of an annual subscription by DCMC on Darebin Council fall outside Council's Procurement Policy because it would not amount to procurement, and therefore also not infringe the 2022 VAGO recommendation regarding recurrent grant recipients?

2. Can Council, in its investigation of options under the resolution of 24 February 2025 at Point 3, also investigate the option of DCMC being funded to its current extent via annual subscription fees, perhaps with industry benchmarking, rather than the recurrent grant arrangement that VAGO has deemed insufficiently transparent?

Response From General Manager Infrastructure &, Operations & Finance

Thanks for the question David.

1. We haven't specifically considered your question and therefore haven't formed a particular view about it. It's quite a different approach to the current arrangement in place through which Council funds DCMC's work. Council can and does pay several subscriptions or membership fees to organisations – for example Council is a member of the Municipal Association of Victoria. However the examples I'm aware of are at much lower levels of funding than Council's current funding for DCMC's work and the nature of services quite different.
1. 2 - In regards to your suggestion that this be investigated as an option, yes we'll test whether paying a subscription fee would be able to be legally considered by Council, if DCMC were to charge one. The report to Council on options has been scheduled for August 2025.

For those watching, it's worth being clear that DCMC is a legally separate organisation from Council, albeit one that Council is a member of and which Council has supported and partnered with for a long time. DCMC's committee is the decision maker on some of the matters being asked about tonight.

• Carmen Lahiff-Jenkins

Does council intend to ramp up actions against cat owners who do not control the wanderings of their pets. I have recently seen a letter drafted to local community in the Moonee Valley LGA regarding cats and the curfew, and cats who persistently annoy other homes. It was very persuasive, and I implore council to review it and this strategy and apply more rigorous safeguards for wildlife.

Response From General Manager Customer & Corporate

Thanks for the question Carmen Darebin has a night time cat curfew in place, which applies from 7pm – 7am, 7 days a week, year round. We are always looking at ways to encourage compliance with local and state laws.

This year Council will undertake consultation for the Domestic Animal Management Plan, which guides Councils animal management activities for the next four years. We would encourage residents to engage with that consultation process and provide feedback to their experiences with domestic animals in Darebin.

- **Jacqui Evans**

Are Council aware of young people who are riding motorised bikes in and around Edwardes lake park?

Response From General Manager Customer & Corporate

Council is aware of activity which would breach the Local Law involving motorised vehicles in Edwardes Lake Park. Council officers routinely patrol Edwardes Lake Park, both during the week and after hours. Council is considering a new Local Law, which is on the agenda for tonight's meeting. This Draft Local Law addresses activities in reserves, like the use of these vehicles and provides more tools to address unsafe behaviour.

- **Matthew Zammit**

1. Has Darebin Council consulted with the Darebin Disability Advisory Committee in relation to the decision to trial hire e-scooters on Darebin streets?
2. Does Darebin Council retain records of how many "Contact Plans" it issues as part of its Complaints Handling Policy, and if so, how many such Contact Plans were issued by Darebin Council between 1 January 2021 and 1 January 2025?
3. It appears as though a segment of the Darebin ordinary Council meeting of 29 April 2024 has been edited out of the meeting video - just after the public question time. What is the reason for this editing of the meeting video and what reasons or powers does Council have to edit or redact video transcripts of meeting proceedings that otherwise appeared on the livestream of the meeting?

Response From General Manager Customer & Corporate

Thanks for the question, Matthew.

1. Officers are currently working on implementing Council's decision on the e-scooter trial, and they recently discussed their work with the Darebin Disability Advisory Committee.
2. Council's current Complaints Handling Policy has a section about "dealing with unreasonable complainant behaviour". Based on this policy, Council may establish restrictions in the way someone can access Council officers or premises, for safety purposes. At present, there is no centralised record for the whole of Council as to how many restrictions have been put in place under this policy. We can share that three formal restrictions on access have been created through the Office of the EO. Council is soon to implement a new Complex Customer Behaviour Policy which provides for the establishment of Contact Plans, with centralised recording.
3. Council edited the livestream recording following a request by a member of the community. This request was assessed by officers and deemed appropriate given the circumstances. Council has various powers incl. those under the LG Act, when it comes to managing council meetings. Decisions like these are made on a case-by-case basis.

Has Council considered or investigated the installation of physical litter traps or netting to protect our local waterways from rubbish washed into them through storm water drains?

Response From General Manager Infrastructure &, Operations & Finance

Thank you for the question, Warwick. Darebin has 26 gross pollution traps, varying in size and servicing different catchments across the municipality.

- **Leon Zembekis**

1. In 2023 I requested Darebin libraries purchase Helen Joyce's book *Trans, When Ideology Meets Reality*. I was told this book was removed from the shelves to be repaired after being vandalised. I asked to be shown the vandalised book and then I asked for it to be repurchased. Both requests were denied. I believe the City of Darebin has censored this book. I would like my previous written requests answered. This attitude of censorship needs to be stopped, and Helen Joyce's book *'Trans, When Ideology Meets Reality'* to be reinstated on the library shelves.
2. Carp are killing Darebin's native water species in our waterways. The Friends of Edwards Lake and Darebin Greens have argued carp be left alone in our waterways against federal and state laws to have carp eradicated. Why is Darebin Council protecting carp and not responding to my written concerns?

Response From General Manager Community

Thank you for your question, Leon.

A library representative will provide a response to you on your specific request by the end of this week. Darebin Libraries' Collection Development Guidelines are used when selecting material for the collection. Selection criteria include:

- relevance and appeal to our community
- authority and reputation of author
- currency and accuracy of content
- cost
- date of publication and availability, and
- existing subject coverage in the collection.

The library receives many customer requests and considers these in accordance with the outlined criteria. Items not purchased may be obtained via inter-library loan if available at another library service. Darebin City Council is proud of the many LGBTIQ+ people, their families and communities who live, work and play in our municipality.

Our Towards Equality: Equity, Inclusion and Human Rights Framework guides Council's work in addressing barriers to equity and inclusion in the community. It goes above and beyond our legislated responsibilities and places Council at the forefront in tackling disadvantage, inequity and exclusion.

Response From General Manager Infrastructure & Operations & Finance

I'm sorry you haven't had a response from us, an officer will contact you this week.

We agree that carp are a problematic pest, however Darebin doesn't allow fishing at Edwardes Lake Park. Some of the key reasons are because the water isn't safe to enter and fish is not safe to eat.

1. Will Council be removing posters on Council-owned childcare centres such as Merri Community Child Care Centre that are currently advertising the state MP for the area?
2. What context has changed since April 2024 when officers were open to Council endorsing the Plant Based Treaty?

Response From General Manager Customer & Corporate

1. In relation to your first question, thank you for bringing this matter to our attention – the team will investigate
2. Regarding your second question, the officer's report included in tonight's agenda shares growing concerns and challenges for our community accessing food.

Councillor Boglis OAM left the meeting at 6:50pm.

- **Timmee Grinham**

As noted in the Council Officers' report to this meeting: 'No feasibility studies or technical reports have been provided to demonstrate that full redevelopment is the most appropriate or necessary option, including for 1 Holmes Street.'
Furthermore: It is unclear if alternative approaches such as refurbishment or retrofitting were explored.

1. Can the Council please explain how the Darebin Council's focus on 'more public housing' actually challenges the government's policy to demolish the tower at Holmes St?

2. Can the Council also please explain whether the focus on 'more public housing' without acknowledging the need to oppose the government's policy to demolish the 44 Public Housing towers is in accordance with the wishes of the Darebin community and the current residents of the Holmes St towers?

Response From General Manager Customer & Corporate

Thank you for your question, Timmee. This is a topic that will be considered by Council tonight.

- **John Nugent**

3. Mayor Could you please advise when this Council will do some improvements to the gardens on the corners of High St and Cramer St outside the Council building. The gardens look untidy there is only patchy grass. This garden was the pride of the Preston central business district
4. Could you please advise me when the unsealed pavement will receive some overdue maintenance on it. The weeds are over growing the pathway and need widening again. When will this work be done? Mayor don't forget there was a petition with 125 signatures who requested this pathway to be sealed and there is 4.8 million dollars in the development fund.
5. My question is about ovals 3 and 5 on Donath west. These ovals have very little grass on them, they also look very dry and dusty. What are Council going to do to bring these ovals back into good playing order?

Response From General Manager Infrastructure &, Operations & Finance

1. Thank you for the question John. These native gardens include several local species that are often mistaken for weeds. While the grass could be greener and plantings refreshed more often, the level of maintenance is a good standard and balances the service level with cost-effectiveness.
2. At this site there is a three-week weed control cycle, last done on March 11–13. Pruning and debris clearing occur weekly, last scheduled today. The teams worked on the granitic sand track at Donath reserve from July to September 2024 to rectify. This task is generally completed annually and will be completed again in July to September 2025. The petition you previously tabled was responded to in May 2024 and council position has not changed since this was shared.
3. These grounds were dry for a short period this summer due to an irrigation failure, which has been fixed. During this time, temperatures exceeded 35°C for the week. With irrigation restored and cooler weather ahead, the grass should establish. The team will monitor the recovery and adjust watering and management as needed. Generally, the grounds meet Council's expected standard and there are ongoing maintenance programs in place to keep them in good shape.

Response From General Manager City Sustainability & Strategy

1. Thank you for your question Peter, Council supports recognition of Aboriginal and Torres Strait Islander people who served their country through the work of the RSL and the Aborigines Advancement League (which runs an ANZAC day service and works closely with the Shrine of Remembrance). These institutions have tended to take a leading role on this for the community.
2. The social housing development on the corner of Kelvin Grove and Townhall Avenue, Preston doesn't provide on-site parking for residents. As part of the planning permit, several provisions were included to address resident parking. The development includes a secured resident only bike cage provides 24 bicycle parking spaces, with three additional ground-mounted spaces, promoting cycling as a viable option. There are 3 car share bays to be installed in the public car park below and a fourth on street in Townhall Avenue. Finally the development's central location to the Preston Activity Centre and access to public transport reduces the reliance on personal vehicles, making it suitable for tenants who do not own cars.

9. CONSIDERATION OF REPORTS

9.1 2 WINGROVE STREET ALPHINGTON - FUTURE USE OF CONCRETE SLAB

EXECUTIVE SUMMARY

Melbourne Farmers Market ('**MFM**') has approached Council requesting use of the large concrete slab ('**Slab**') which was installed at 2 Wingrove Street, Alphington by C Fulton Pty Ltd ('**Fulton**'). Fulton installed and currently own the Slab and are responsible for its removal and make good of the site to bring it to its original condition. Removal is costly and complex due to the site being a former landfill with cost estimates of several hundred thousand dollars (\$366,600) depending on the conditions under the slab. Removal will be required within the next 5 to 20 years as the slab is not in good condition and depending on the outcomes of Council's work to develop a masterplan, although there is not an immediate practical need for removal.

This report seeks a decision of Council as to whether or not to grant the request from MFM for use of the slab and thereby also to release Fulton of their current responsibility to make good.

This is an unusual situation because granting a new licence without a commitment by a new licensee to remove the slab would transfer significant to Council associated with future removal of the slab. This would require Council to allocate funding of several hundred thousand dollars for making good and these funds could not be used for other purposes. Considering this opportunity cost, it is recommended that Council maintain the requirement of the outgoing licensee to make good unless any new licensee is willing and able to take on the make good requirements.

MFM currently operate a farmers' market, food hub, commercial onsite café and community meeting space in the South-Western corner of 2 Wingrove Street under a licence with Council. The market is highly valued by the local community. MFM have requested use of the Slab to facilitate the farmers' market, as their current space is smaller and faces some issues with dust and mud. They have indicated that they would relocate the Market to the slab and off the current location.

MFM have indicated that they do not have the financial capacity to consider taking on removal of the slab and it is not regarded as realistic to seek that they cover the very high costs, although it is would be technically possible to offer them a licence on the basis that they took on responsibility for future removal.

Following the Council decision on 16 December 2024, all decisions relating to short, mid and long-term use of 2 Wingrove Street, Alphington, including establishment or conclusion of licences, are to be reported to Council for decision. Accordingly, a Council decision is sought on MFM's request for a licence for the area covered by the Slab.

EXECUTIVE SUMMARY

This report is seeking clarification of the resolution made by Council at its meeting on 18 December 2023.

On 18 December 2023, reflecting Council's long-standing and deep commitment to high quality Early Years Services, and taking into account submissions received from the community, Council resolved to enter into new leases with each of 18 (not-for-profit) Early Years Services Associations (**'EYS Providers'**), for an initial five-year term with a further five-year term at the EYS Provider's option (**'New Leases'**).

The decision included the following elements on which this report is seeking clarification (emphasis added):

- (4) *Enters into a five-year lease commencing 1 January 2024, with a 5 year option for a further lease term (at the tenants option) with each of the 18 (not-for-profit) Early Years Services Associations on the following terms and conditions for the provision of Kindergarten and Childcare services at the various 18 Council-owned premises:*
- a. *An annual rent of \$104 per annum plus GST that is fixed for the term of the Lease.*
 - b. *The tenant's lease conditions relating to liability towards outgoings costs **will remain the same at its current agreement.***
 - c. *The tenant's lease conditions relating to obligations and liability for maintenance costs **will remain the same as its current agreement.***

Since the above decision, it has been identified that not all conditions of the previous leases which ran from 2014-2023 (**'2014 Leases'**) were enforced in practice during the final term. This was an administrative control issue which resulted in some costs not being passed on as they should have been and as had been agreed by all parties in the conditions of the lease.

In regard to the lease terms moving forward, this report seeks clarification as to whether Council's decision is to proceed with the relevant lease terms and conditions as previously agreed *in writing* by all parties in the 2014 Leases, or if it is the intention to proceed with the lease terms as *enforced* during the last term of the lease.

Given the nature of the highly valued and impactful community services and the disruption that it would cause, it is not recommended that Council pursue recouping of costs under the previous lease term.

The submission is informed by lessons from previous social housing redevelopments in Darebin and prior advocacy efforts that prioritise housing affordability and tenant protections. The proposed submission includes:

- seeking commitments from the State Government to retain and expand social housing, including in Darebin
- seeking information to be publicly released that:
 - demonstrates refurbishment was considered before demolition was determined as the most feasible option, including for 1 Holmes Street, Northcote.
 - considers delivery models like the ground lease model that retains land in public ownership.
 - considers social and economic long-term impacts of gradually replacing public housing with private and community housing.
 - demonstrates how the project will meet the community's needs, including dwelling typology, and access and inclusion needs.
- early planning and inclusive engagement involving existing residents, the community and local government to mitigate impacts of dislocation and consider return pathways for residents.
- assurance of high-quality dwellings, urban design, environmentally sustainable design and consideration of local context.

If Council supports making a submission, Council Officers will lodge a submission prior to the 31 March 2025 closing date in alignment with Council's decision.

9.6 PLANT BASED TREATY AND FOOD RESILIENCE SCOPING STUDY UPDATE

EXECUTIVE SUMMARY

Research shows that food insecurity is growing across Darebin. The Food Resilience Scoping Study will support Council to better understand this risk and the options it has to strengthen community food resilience.

Council endorsed the Plant Based Treaty in April 2024. The Treaty a grassroots initiative creating bottom-up pressure for the negotiation of a global Plant Based Treaty as a companion to the UNFCCC Paris Agreement. No work has started to implement the treaty, but a number of existing Council initiatives are aligned to the Treaty.

This report puts forward two options for considering the Food Resilience Scoping Study and the Plant Based Treaty.

CONTAINER DEPOSIT SCHEME - PROGRESS UPDATE

EXECUTIVE SUMMARY

The Victorian Container Deposit Scheme (CDS) is a State Government Program designed to encourage people to recycle their used drink containers. Users receive a 10-cent refund for every eligible drink can, carton and bottle they return. The program commenced on 1 November 2023.

Darebin has long advocated for a program like this to improve sustainability outcomes and reduce littering and it welcomed the State Government's announcement.

Visy Recycling is the scheme operator in Darebin and is responsible for establishing and maintaining refund collection points.

In October 2023, Council confirmed its commitment to the Container Deposit Scheme, endorsing its commitment to identifying suitable sites for the scheme. Council also committed to assist in the roll out of the CDS by promoting the scheme to the broader community, as well as sporting clubs, businesses and community groups.

In 2024, Council successfully assisted in the delivery of a Reverse Vending Machine (RVM) to the Council-owned Ray Bramham Garden's Carpark, located behind the Darebin Art's Centre in Preston. This site is now leased to Visy Recycling.

Over the past year, Council has been in discussions with Visy about the best locations for refund points. Visy and Council both concur that commercial centres are the highest priority sites, given co-benefits of helping bring people into commercial areas, and by providing the best access for community.

Recently, Visy have reported that the sites currently available to the Darebin community, as well two proposed sites through private retail offer the needed access for the Darebin community, and thus they are currently not seeking any further Council sites.

Visy and Council have done work on several potential sites, and if this was needed in future, the preliminary work would be revisited by the two organisations working together.

The purpose of this report is to note Council's ongoing support for the CDS, highlight the current CDS network across Darebin and to present a summary of Council's work undertaken on the feasibility of potential RVM sites in Darebin.

Any decisions about leasing Council land on the identified sites would come to a future Council Meeting for consideration in due course.

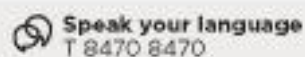
