6. QUESTION AND SUBMISSION TIME

The Chairperson, Cr Messina, responded to the following questions submitted for Public Question Time.

Renato Maddalena of Northcote

Question 1:

For the laneway behind 5 Howitt Street, why does a unmade laneway determination put maintenance and duty-of-care on abutting residents who do not own the laneway that was offered by Darebin council to be bought by them decades ago and never occurred? Question 2:

If maintenance and care of the laneway behind 5 Howitt Street is the responsibility of abutting properties, how can people in their 70s with health issues carry out these tasks. Particularly, when the soil is up to 150mm in depth in some sections.

Question 3:

Can Council advise when the laneway behind 5 Howitt Street became classified as an unmade laneway; when residents were notified; and how this classification puts the onus of maintenance and care of the laneway onto the residents who do NOT own this land?

Response

Typically, roads that are on the register of public roads receive maintenance services from the Council. Currently this laneway is not on the register.

However, Council staff have reviewed the status of the laneway behind Howitt St Northcote and have decided that it warrants being added to the register, and as such, it will now be added to the Council schedule for maintenance and cleaning.

We're hopeful that it will receive its first service within the next 4 – 6 weeks

Brian Fairman of Preston South

I have lived in Darebin my entire life, at various addresses.

Its Time (a familiar phrase) to resolve the traffic hazard on Milton Cres. Preston South.

I have driven this curving road for many years and witnessed near misses many times. I have even seen a car swerve to miss a 3 year old child run down the street (near a children's playground)

However, today Thursday 25th January, it was my misfortune to experience an accident. I approached the 'dangerous' corner with great caution, and a car from the opposite direction entered my side of the road. I stopped and was stationary, however the car kept coming and drove into me.

I request that the Council take 'action' to minimise the harm caused to my fellow Darebeens?

Action could include:

Gathering evidence of past 'accidents' on this road, to support a VicRoads application for change.

Changing the 'parking' arrangements in the street, particularly near the corners and bends in

the road.

Change the speed limit on the road, or prohibit traffic to one-direction under the Local Government Act Schedule 11.

Write a letter to the Victorian Roads Authority requesting a 'one-way' direction be placed on Milton Cres.

At the moment I am gathering Petitioners to support some form of action, Council could do the same!

What will Council do to resolve this long standing traffic problem?

Response

A review of the crash data shows that there have not been any reported accidents on Milton Crescent from 2014 to 2020 (the latest year for which data is available).

The posted speed limit on Milton Crescent is 50km/h. Council continues to advocate to Department of Transport to reduce speed limits in residential areas to 40km/h, but this process takes time. Milton Crescent is not included in the areas being considered for changes this year.

Traffic data collected in late 2016 found that most vehicles on Milton Crescent are already travelling at a speed of less than 30km/h. This is unsurprising given that it is a narrow street with a number of bends. Parked cars can also help to encourage slower driving. The same dataset also shows traffic volumes on the street are within and acceptable range for the type of road and does not suggest that Milton Crescent is being used as a rat-run for through traffic.

There are plans to investigate parking changes on Milton Crescent. Letters will be sent out to all households and businesses on the street in February 2022 to notify them of the process and give them instructions on how to participate.

The Your Street, Your Say project will provide an opportunity to consider more significant changes to the street in 2022/23.

Brian Fairman of Preston South

We, the concerned residents in Milton Cres and surrounds, request that Milton Cres be included immediately in the current: 'Your Street Your Say' consultation process, either inclusive with, or separate to, Part A consultations.

Response

I'm sorry, but we aren't able to bring forward the Milton Crescent investigation into the current financial year's investigations.

Council is planning to investigate the Milton Crescent area soon. We will investigate and consult on needs for transport and safety next financial year via the Your Street Your Say program. Officers are also planning to approach residents of Milton Crescent and surrounds in early 2022 to consider possible improvements to parking.

I hope this gives you a path forward.

Serena O'Meley of Reservoir

On 4 September 2019, Terry Mason represented the Ruthven Community Reference Group (CRG) in a meeting with the Darebin Aboriginal Advisory Committee (DAAC) to discuss recommendations for naming the park at the site of the former Ruthven Primary School. On 29 October 2019 members of the CRG met with Darebin's Aboriginal Contact Officer, and

representatives from the Wurundjeri Land Council for a site tour and to further discuss the naming in the Woiwurrung language.

On 24 May 2021, I asked at a meeting of Darebin Council that naming of the site be treated with some urgency to overcome confusion with W.R. Ruthven V.C. Reserve, both in terms of emergency services which may be called to the site, and in relation to securing government grants for the improvement of the park. I was told in response that the naming was in progress. Since that time, a bridge and a sports stadium have been named but not the former Ruthven Primary School site.

On 28 January 2022, a Council Officer emailed me as follows, "Renaming of Ruthven Park – preliminary works have commenced with internal staff to start this process in the new financial year, subject to adoption of the budget."

Because the site does not have an existing name there are far less hoops to jump through in terms of the Geographic Place Names Committee; if the name is unique it should be quickly accepted. Therefore, this further indefinite delay is unacceptable.

Question 1

Can you explain if/why the process for naming the former Ruthven Primary School site is apparently being started from scratch and why the Council Officer believes there are budget implications attached to the naming?

Response

The Parks and Open Space unit is following the renaming process as determined by the Wurundjeri Woi- Wurrung Heritage Corporation. The process to rename the former Ruthven Primary School in the Woi Wurrung language recognises the Wurundjeri Woi Wurrung as the Traditional Custodians of the land and waters in this area.

This process has commenced, and Officers are optimistic that the complete naming process will be finalised by late 2022, however this may be earlier.

Following the statutory process for renaming sites, the shortlisted names will go through a community consultation process. Following determination of the selected name by Wurundjeri Woi-Wurrung Cultural Heritage Aboriginal Corporation, we will make application to Geographic Names Victoria (GNV). GNV is currently in the process of releasing it's the Naming Rules for Places which is expected in February 2022.

Question 2:

What expense is likely to be involved and if there is an expense why it is not already budgeted?

Response

The cost associated with the application to Wurundjeri Woi- Wurrung Heritage Corporation for names and the ongoing licence is approximately \$3,000. There are no budget implications that will affect this process.

Question 3:

What steps will Darebin Council take to hasten the naming process so that it can take effect in this financial year?

Response

Darebin City Council is following the statutory process applicable to this matter and is unable to influence the timeline, however as stated above we are keen to complete the process promptly.

EXECUTIVE SUMMARY

This report provides Council an update on the completion of the statutory procedures to discontinue the road adjoining 1 and 3 Merrilands Road and 4 Hughes Parade, Reservoir.

The report further recommends the land from the discontinued road be sold to the owners of 4 Hughes Parade, Reservoir, by private treaty in accordance with Council Policy.

Officer Recommendation

Discontinued road adjoining 1 and 3 Merrilands Road and 4 Hughes Parade, Reservoir

That Council:

- 1. Notes that following completion of the statutory procedures under section 206 and clause 3 of Schedule 10 to the Local Government Act 1989 for the discontinuance and sale of the road adjoining the rear of 1 to 11 Merrilands Road, 4 to 10 Hughes Parade and 12 Asquith Street, Reservoir, the owners of both 1 and 3 Merrilands Road, Reservoir have declined to purchase from Council the land adjoining their properties shown as Lots 10 and 8 respectively on Title Plan TP967921V (version 8) in Appendix A.
- 2. Directs that the land from the discontinued road, shown as Lot 5 on Title Plan TP967921V (version 6) in **Appendix A** be sold to the owners of 4 Hughes Parade, Reservoir, by private treaty in accordance with Council Policy.
- 3. Authorises the Chief Executive Officer to sign all documents relating to the sale of the land.
- 4. Transfers to itself any land from the road not sold.
- 5. Authorises the Chief Executive Officer to undertake all actions required to transfer to Council any land not sold.

8.4 INVESTMENTS RELATING TO NUCLEAR WEAPONS

EXECUTIVE SUMMARY

In response to a Notice of Motion at the Council meeting on 23 August 2021, a review of Council's investments in term deposits portfolio was undertaken to check on banks and financial institutions who have either direct or indirect investments with companies associated with production of Nuclear weapons. Of the fifteen banks and financial institutions where Council holds term deposits, eight of them are either Nuclear weapons free or in the process of excluding Nuclear weapons from their investments. The remaining seven have Nuclear weapons related investments.

To ensure embedding exclusions of nuclear weapons in Council investment policies in alignment with the Climate Emergency Plan (Key Direction 6 – Fossil Fuel Divestment), It is proposed that the following wording could be incorporated to give effect to the intent of the Notice of Motion.

"Treaty on the Prohibition of Nuclear Weapons

Council does not invest directly in companies that produce nuclear weapons. Wherever practical, Council preferences financial institutions and investment products that do not directly or indirectly fund any activities in the Arms industry."

The Investment Policy is reviewed annually by the Audit and Risk Committee and was last reviewed in March 2021. The Investment policy is an operational policy approved by the CEO and was last presented to Council at its meeting on 19 June 2017.

It is recommended that the draft Investment Policy at **Appendix A** be adopted by Council.

PURPOSE

The purpose of this report is to award contract CT2021114 for Darebin Resource Recovery Centre - Concrete Retaining Wall, Pavement and Drainage Construction.

EXECUTIVE SUMMARY

The replacement of the existing waste transfer deck retaining wall at the Darebin Resource Recovery Centre (DRRC) was identified as high priority infrastructure work due to the deteriorated condition of the existing structure. Since completion of the original structural assessment, one section of the retaining wall has been further damaged by a truck impact and another has failed as a result of the September 2021 earthquake.

The appointment of an experienced contractor for the construction of the altered design for the replacement of the inadequate civil infrastructure at the DRRC separation facility was sought through a public open tender process in accordance with Council's Social and Sustainable Procurement Policy and procurement guidelines.

The new works will be undertaken successively over four phases to minimise any interruption to the recycling operations of the operators of the DRRC. A tender evaluation panel has completed a detailed evaluation process, financial checks, risk assessment and recommends awarding the contract to the preferred tenderer.
