#### 5. QUESTION AND SUBMISSION TIME

The Chairperson, Mayor Messina and the Chief Executive Officer, responded to the following questions submitted for Public Question Time.

#### Christopher Wilkinson, Reservoir

Incidents of hoon driving have only become worse. I have photos showing the state of the road. There are bits of tyre and burnt rubber everywhere. The local business owners and people living in the area have had enough.

Last meeting I asked what was being done, now I am asking what is the timeframe? It is only a matter of time before someone is seriously injured or killed.

#### Response from Chief executive Officer, Sue Wilkinson

Firstly, I would like to thank you for taking the time to discuss hoon driving on Radford Road with Council officers.

Council is very concerned by reports of hoon driving. I encourage you to please continue to report incidents of hoon driving and speeding to Victoria Police.

Should you, or any other concerned resident, require any assistance with this, I have asked that Council officers provide this support. Officers will continue to work in close

contact with Victoria Police in order to assist them with their monitoring and enforcement activities.

Furthermore, Council will investigate if physical changes to the road could assist to deter this behaviour, however it is important to know that this would not be a quick solution. Each year, Council undertakes approximately 15 transport safety projects across the municipality. With changes to roads often taking two to three years from the initial investigation to the final construction.

At its May Council meeting, Council will make a decision about its schedule for investigating road safety improvements. At this time, we will be clearer about timing for safety projects and our next steps.

#### • Mr Reid, Reservoir.

Please advise what is being done in both the short and long term to address the hoons that frequent Radford Road. A hoon died on Radford Rd after doing a several hundred metre burnout back in 2019. Two young families (including ours) now live on Edwardes St at the end of Radford Rd. Will it take the loss of life of an innocent member of public or one of our young children for you to finally wake up and take some action.

#### Response from Chief Executive Officer, Sue Wilkinson

I refer the previous question and response and request that you continue to report any incidents of hoon driving and speeding to Victoria Police.

I have asked, that a responsible Officer contact you to discuss your concerns.

This evening, we have received two questions about road closures near Bell station from Ms Kate Da Costa and Mr Ewen Baker. They are not in attendance and their question is the same. I will read and respond to them both together.

#### Kate Da Costa and Ewen Baker, Preston

As Council is I aware, residents of Gertrude Street, Preston unanimously oppose allowing motor vehicle access to the new Bell Station car park via our residential street.

Prior to Council elections last year, many of you were contacted directly about the issue. During the election campaign period, many Councillors expressed support for the residents in the form of permanent closure of Gertrude Street to through traffic. Council received a petition in October last year, seeking a trial road closure of our street, along with Adeline and Esther Streets. The petition was tabled at the Council meeting in November 2020 with the support of many of you. Council officers subsequently advised us that a formal process of community consultation needed to take place before any final plans could happen. This process happened in February 2021. We were then given an indicative timeline of May 2021 for the trial road closure to actually be implemented. In April 2021, there has been no update for the community on this urgent and critical initiative.

Why not? Will the Council commit to implementing a trial road closure of Gertrude Street as promised? When will it happen?

#### **Response from Mayor Messina**

Council will consider all community feedback from the recent consultation and any options for protecting local streets from extra traffic at our next Council meeting on the

26 April. The Road Management Act details the formal decision making process that Council must use with respect to any road closures.

Our officers will update interested community members in the next week so that everyone will know about Council's upcoming meeting.

I would also like to note that we have also been advocating to the state government for many months for the design to be adjusted so that traffic does not have to travel down local streets, in order to access the commuter carpark.

We are disappointed and frustrated that so far the state government hasn't changed their design. I encourage you to contact the state government directly – as hearing from the community directly is often incredibly important for issues such as these.

#### • Justin Passaportis, Preston

Mayor, Councillors, thanks for the opportunity to ask a question.

Mayor, thank you for meeting with our concerned resident group last year on 6 December and taking the time to do a site visit of the LXRP works and the area around Bell Station.

You saw first hand of the real safety concerns we have and how dangerous it will become with traffic rat running these streets to access the new car park if the current plan goes ahead for the level crossing removal here.

One of the suggestions you made on the day was to investigate the prospect of Darebin using the Open Space fund to purchase a small section of the VicTrack land on the west side of the station given that the state government has shunned the Darebin community at every step of the process.

This small space could then be used as the entry to the new car park- where there are no residences and there is direct access from Bell Street- a win for motorists, a win for pedestrians and a win for the community.

Please can you tell us where this plan is up to?

Please can you detail what specific actions Council is taking to ensure the LXRP and state politicians finally listen to the Darebin community and take access to the new car park west of Bell Station?

#### Response from Chairperson, Mayor Messina

I have been advocating for that proposal through our officers on more than one occasion. Unfortunately, that land is not up for sale and I am following the process through our officers to ensure that we continue to advocate for the acquisition of that particular pocket of that west side so that we can have access.

As per my response to previous questions, Council has been considering community feedback from the recent consultation and any options for protecting local streets from extra traffic and further advocacy will be considered at its next meeting on 26 April. The Road Management Act details the formal decision managing process that Council must use in respect to any road closures.

Our officers will also update interested community members in the next week, so that everyone knows about Council's upcoming meeting.

I would also like to note that we have also been advocating to the state government for many months for the design to be adjusted so that traffic does not have to travel down local streets, in order to access the commuter carpark.

#### Justin on behalf of Mitch Wall, Preston

Since 2018, the community has been writing to the Minister for Transport infrastructure, the Member for Northcote, the member for Preston hoping to 'drive' this project, as the Premier had promised, and have been either ignored or offered mere lip service.

This has become a situation where the state government is doing whatever they want, and casually ignoring the things that really matter to the residents of Darebin like keeping local streets local.

When is Darebin Council going to stand-up with the local community to the LXRP and State government so they don't tarnish our neighbourhood? When is Council going to pushback on LXRP and ensure that the new Bell Station car park is only accessed by an entry from the western side of the trainline?

#### Response from the Chairperson, Mayor Messina

Council has spent many hours advocating on behalf of residents, moved many motions to ensure that your voices are heard with the state government, and not only with the local members but also with the LXRP. Additionally our Chief Executive officer has been advocating for this position with the Chief Executive Officer of the LXRP.

I am disappointed that we have not as yet made any progress in terms of actually having that project design changed to align with our mutual vision. Darebin Council will continue to advocate for this, but it's also important for the state government to keep hearing from community directly.

#### Maddy Maitri, Preston

On Saturday, 27 March 2021, the LXRP deliberately cut down trees in the Bell Station precinct in an area clearly designated an "environmental no go zone." The removal of large trees of great significance to our area and wildlife has caused considerable distress in our community as we have been engaging with LXRP to ensure we retain as much green space as possible. As soon as the actions were witnessed, LXRP were alerted and eventually the works were halted, but not before most of the damage had already been done. Despite numerous attempts the LXRP have failed to acknowledge the incident or provide any explanation for what happened.

What will the Council do to ensure that the LXRP and their contractors are held accountable for their blatant disregard of environmental protection measures?

#### Response from the Chairperson, Mayor Messina

Council is monitoring and pressure testing any tree removal by the LXRP and has so far protected 29 trees that would have otherwise been removed. Originally, the LXRP planned to remove all of the trees from this site – 63 trees in total. Council's specialists called for many of these to be protected – and the LXRP now propose to remove 34 trees.

In regard to the trees that you have asked about, the LXRP previously proposed retaining them, however a recent safety audit determined that they could not retain them safely. Our specialist staff have looked at the detail of this and ultimately agreed that unfortunately there is not a viable option to keep them.

The safety issue relates to exposed roots and the slope near the tree. This has meant that the tree and surrounding ground is unstable.

I am very sorry to hear that you haven't heard from the LXRP. Our team will call them and see if we can help ensure you get a response.

#### Soula Garlaounis (on behalf of Darebin Greek Women Senior Citizens Group)

Hi My name is Soula and I am the president of the Darebin Greek Women Senior citizens Group.

Our group meets every Wednesday at the Reservoir Library, but we are allowed only 22 people every Wednesday. Our members are very unhappy that they have to come to the club once a month (80 plus members divided by 22).

As I understand the meeting venue upstairs is approximately 90 square metres, and the newest rules from the Victorian government are 1 person per 2 square metres if that is correct then we can have approximately 45 persons in every meeting and not 22 as it is today.

I would appreciate a review of the rules that apply.

#### Response from the Chief Executive Officer, Sue Wilkinson

The Reservoir Community and Learning Centre is operating its function room based on a COVID safe plan. Groups are required to maintain 1.5 metres of social distance in addition to the calculation of the 1 person per 2 square metre rules.

The furniture has been set up to maintain this COVID safe operation, in addition to ensuring that safe movement and egress through the room is maintained. Officers have recently reviewed the layout of the room's furniture set up, and users are being advised that the capacity can increase to 28 people moving forward.

Like you Soula, we hope that Council facilities will be back to operating at full capacity very soon, but we will keep you posted.

#### Ruth Jelley, Northcote

My question relates to the decision-making processes and standards for Darebin councillors. On this matter I will refer to last month's debate over whether or not to proceed in commissioning a feasibility study into a trial of pop-up bikes lanes on High St Thornbury/Northcote.

My point is that anecdotal evidence falls a long way short of the level of evidence that the community expects its councillors to draw upon in making decisions on this council. At the previous meeting, Councillor Rennie noted that the Council employs its own traffic engineers, on whose expert advice the council draws upon in making decisions on behalf of this community. Why do councillors not want to make use of these experts and many more involved in collating a feasibility study into pop-up bike lanes on High St, complete with proposed designs with which the council can engage in community consultation?

Will councillors make a commitment to the Darebin community to base their decisions on the evidence presented, and where relevant, to commit to seeking evidence before proceeding to a vote on any matter?

#### Response from the Chairperson, Mayor Messina

All Darebin's Councillors take their responsibility as elected representatives of the community and decision makers seriously. As a Council, we make decisions that are informed by all of the information available to us, including briefings, Officer recommendations and community opinion. On this occasion Council made a decision that was different to the Officer recommendation, which does happen. The reasons for this outcome are generally explained and clear through the debate on the item being considered.

#### Claire Layden, Reservoir

Regarding the Northern Reservoir Streets for People Project, can you please confirm if Council are definitely committed to complete the works in the East side of the corridor, i.e. New Street / McMahon Rd / Boldrewood Pde roundabout, in particular the pedestrian crossings for McMahon / Boldrewood roundabout? And whether designs for this stage will be included in the 2022 budget?

#### Response from the Chairperson, Mayor Messina

The draft budget that Council is considering tonight proposes \$30,000 for the location you have asked about. This is proposed for detailed design for the McMahon / Boldrewood Parade intersection and the design includes pedestrian crossings. Construction would occur in a future year.

In June, after Council has considered community feedback, it will confirm its projects for 2021-22.

#### Bill Jennings, Preston West

- 1. The Community group 'The Northcote Community and Golf Hub' are grateful to Council for informing us that highest number of games of golf for the last eight calendar years, over 22500 games, were played at the Northcote Public Golf Course last year, even though for one third of 2020, golf was not allowed to be played at Northcote Public Golf Course due to the Covid 19 restrictions. Can Council confirm what I am observing anecdotally at the Northcote Public Golf Course that there appears to be a continuing trend of a high number of people playing games of golf there in this calendar year? Could Council report on the number of games played January through March inclusive in 2021?
- 2. Further to Question 1 above could Council regularly update the community with these numbers on a quarterly basis?
- 3. With respect to the Consultation process regarding the Northcote Public Golf Course, could Council advise in what format will the consultation take place? When can the stakeholders expect to be contacted and what is the timeline of the consultation including when the final report will be submitted to Council?

#### Response from the Chief Executive Officer, Sue Wilkinson

- 1. In January 2,803 rounds were played and in February 2,270. Monthly figures for March have not yet been finalised but can be provided as soon as they are (anticipated to be within one week). As COVID restrictions were lifted, golf was able to be played prior to many other activities and experienced higher than normal participation this trend was experienced at both Darebin Golf courses but we are not sure if this is a lasting trend.
- 2. A quarterly update of rounds played can also be provide on ongoing basis.
- 3. Consultation will commence in July 2021. The initial phase of consultation will involve broad and extensive consultation with many stakeholders through means such as: surveys; pop up booths; targeted conversations with identified key stakeholders etc. This initial information will be analysed and presented to Council later in 2021 for consideration on next steps.

#### David Schulze, Reservoir

Can the council explain why the consultancy fees are so far over budget, and provide a breakdown of what projects the consultants have been engaged for?

#### Response from the Chairperson, Mayor Messina

The consulting fees for 2020/21 are 10% over the budget, due to the Local Government Power Purchasing Agreement that Darebin Council is leading on behalf of 47 Councils. The costs incurred and current overspend will be offset by contributions that will be received from the other 47 Councils.

#### Jan Powning

I wrote a letter to yourself (including all Councillors) and CEO and would like to confirm if this letter has been received. It has eight questions in it. Four questions around road safety, one question about street planting of trees and three questions in relation to building approvals.

- 1. I ask these in relation to the Junction of Separation Street and Andrew Street Northcote, what is being done there to provide a safe crossing space for people to use when accessing the park or the plaza? Who is accountable for that decision and if this could be considered as part of the budget for safety?
- 2. The second question relates to Clarendon Street, between the market and the Council owned car park opposite. It is very unsafe, when will a crossing be installed and who is accountable for neglecting it so far.

- 3. The third question around road safety, specifically, the corner of St David Street and Darebin Road is a known black spot and risky to try to cross and has had many near misses. Why has nothing been done to protect from that, when will lights be installed or some other substantial traffic calming and safety device measure?
- 4. Lastly, a question around planning decisions, some are so bad that the VCAT has recently overturned a decision made by this Council, in relation to 1 Wardrop Grove, Northcote.

#### Response from the Chairperson, Mayor Messina

You are only permitted to ask three questions, we can take your additional questions on notice and we have received your email. I will ensure that the General Manager and Chief Executive Officer respond to your questions.

#### Katarina Balasi, Preston

Issue with trees on the naturestrip of property and I would like to request that someone come and inspect these trees not just the width, but also the height of these trees.

#### Response from the Chief Executive Officer, Sue Wilkinson

I have requested that the General Manager Operations and Capital send out an officer in the next week to discuss the issue with Ms. Balasi.

#### 7.1 DAREBIN 2041 COMMUNITY VISION

#### **EXECUTIVE SUMMARY**

The Community Vision is a new requirement introduced through the Local Government Act 2020. The Community Vison must be for at least 10 years and must be in place by 31 October 2021, taking effect from 1 July 2021. The Darebin 2041 Community Vision is based on a 20-year horizon, enabling our community to consider the future of Darebin for the next generation.

The Darebin 2041 Community Vision has been developed through the Design Your Darebin 2041 engagement program, which included the establishment of a Deliberative Community Engagement Panel. Community Engagement commenced in December 2020 with broad engagement and the results of this engagement informed the Deliberative Panel's work to develop the Darebin 2041 Community Vision. The Deliberative Panel met virtually 3 times between 28<sup>th</sup> February and 11<sup>th</sup> March and completed further work through an on-line forum to finalise the Vision throughout March 2021.

The Vision provided below remains unchanged from when it was presented to Council on the 29<sup>th</sup> March 2021.

#### **Darebin 2041 Community Vision**

Darebin is equitable, vibrant, green and connected. We respect First Nations peoples, our diverse communities and places. We are committed to a sustainable, climate safe future.

#### **Priorities**

#### Darebin - a city that known for:

#### Vibrant, Respectful and Connected

- being respecting and recognising Aboriginal and Torres Strait Islander communities' values, living culture and practices
- connecting, valuing and including our diverse communities
- its artistic community; not just venues and locations, but the people

#### **Equitable**

- being a place that has safe and secure housing for all
- providing for all aspects of health and wellbeing through all stages of life
- being a 20-minute city; where we can safely access amenities and services close to our homes

#### **Green and Sustainable**

- its commitment to a safe climate future for all
- its clean access to the outdoors, protection of wildlife, land and water
- preserving amenity and where business and development align with preserving natural assets and strengthening community
- having a diverse and healthy food system that is connected and inter-generational

#### Officer Recommendation

#### 7.4 DRAFT BUDGET 2021–22

The annual budget is an essential planning and resource tool produced each year. The development of a considered budget is vital to the ongoing operational and financial viability of Council. The budget sets out the expected income and expenditure for operational, strategic and capital activities for the coming year and also incorporates Council's rating strategies. The budget 2021/22 is informed by Council's draft Community Vision 2041, draft Financial Plan 2021-31, draft Council Plan (incorporating Municipal Public Health and Wellbeing Plan) 2021-25 and draft Rating and Revenue Plan 2021-25.

The draft 2021-22 budget seeks to continue Councils proactive approach to prioritising efforts to supporting the community impacted by the COVID pandemic. Towards this, the budget contains a significant financial assistance package featuring:

- A \$50 spend local voucher to pensioners who are property owners
- A \$30 spend local voucher to residential property owners
- A spend local voucher Darebin residents and pet registration subsidy for Darebin residents who are eligible Job Seekers
- Continued support to traders including through fee waivers such as footpath trading fees
- Fee waivers in Art venues and Community Hubs
- Leisure and Recreation vouchers and discounts
- Continuing opportunity for all ratepayers to defer 2021/22 rate payments to 30 June 2022

It is important to acknowledge that Councils own financial position has been impacted by the pandemic and this is expected to continue at least in the short term. In responding to this challenging period, it is critical that Council maintains a sound financial position so that it can meet its financial obligations and ensure that it is in a position to support the needs of the Darebin community into the future.

The budget documentation forms part of a comprehensive public accountability process and reporting that includes:

- A 20-year Community Vision
- A 4-year Council Plan incorporating the Municipal Public Health and Wellbeing Plan
- A 10-year Financial Plan
- A 4-year Rating and Revenue Plan
- An Annual Report

The draft budget contains the information specified in the *Local Government Act 2020* ('the Act') and all details required by the Local Government (Planning and Reporting) Regulations 2020 ('the Regulations'). The financial statements included in the draft budget have been prepared in accordance with the Local Government Model Financial Report.

## 7.5 APPROVAL OF MAYORAL AND COUNCILLOR ALLOWANCES FOR PUBLIC DISPLAY

#### **EXECUTIVE SUMMARY**

An important reform of the *Local Government Act 2020* (2020 Act) was the transfer of responsibilities in determining Mayoral, and Councillor allowances to the Victorian Independent Remuneration Tribunal (the Remuneration Tribunal).

However, until the Remuneration Tribunal makes its first determination on allowances, the allowance framework under the *Local Government Act 1989* (1989 Act), continues to apply, despite the repeal of those relevant provisions last year. Section 39(6) of the 2020 Act provides for this transitional arrangement.

The Minister is expected to request the Remuneration Tribunal to make a determination in late 2021.

Accordingly, Council is required to review and determine the level of Mayoral and Councillor Allowances within the period of six months after a general election or by 30 June whichever is later. The purpose of this report is to review and determine allowances for the Mayor and Councillors and to commence public consultation under section 223 of the Local Government Act 1989.

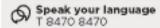
