#### **Council Resolution**

#### 5. QUESTION AND SUBMISSION TIME

The Chairperson, Cr Le Cerf, responded to the following questions submitted for Public Question Time.

#### Mike Chance, Thornbury

"Why had Lentil as Anything Thornbury been granted a liquor license until 11pm at night when there have already been multiple complaints against them for noise, rowdy behaviour of patrons and damage to property from their patrons?"

#### Response

"The Victorian Commission for Gambling and Liquor Regulation is the authority which issues and amends liquor licences. Complaints about a licensee or its patrons may be referred directly to the Commission for investigation.

Council's involvement in liquor licensing matters is limited to considering licence applications referred to it for comment and lodging an amenity-based objection where this is considered appropriate. In determining whether or not to lodge an amenity-based objection, Council has regard to the operating track record of the business, as indicated by the presence or absence of complaints, the business' complaint-handling and whether any material issues remain outstanding.

In relation to Lentil as Anything Thornbury, Council's customer service log records a single complaint against the venue in relation to noise, dating back on 19 July 2016. The complainant, a nearby business owner/occupier was aggrieved by noise associated with staff congregating outside for drinks after closure and noise from playing instruments outside. Council's Senior Planning Investigations Officer raised the concerns with the store manager in a face to face meeting on 25 July and subsequently advised the complainant of the intervention with a request to call back if there were any further noise instances. In the absence of any further complaints being received the matter was closed.

In the absence of any ongoing issues relating to the venue being brought to Council's attention it saw no valid reason to object on amenity grounds to a comparatively modest extension of trading hours."

#### Denis Gibson, Preston

"Following on from the email below and lodging a question to Council, I was given an assurance from Council that initiatives would be undertaken including the use of contractors to clean up the footpath area in the vicinity of Dundas Streets and Plenty Road.

I need to advise that despite the initiatives that were promised, the condition of this area has not improved as evidenced by the photos I've attached which were taken yesterday morning. I will admit that the condition of the footpath was extremely bad yesterday but it is indicative ongoing condition of the footpath in this area. I recall that the main thrust of Council initiatives indicated to me last year was that contractors would be used to regularly clean the area. I suspect this isn't being done but if it is, it's not enough to make a permanent improvement to this area.

There needs to be another approach to ensure that Aldi and the Body Corporates for the shopping/residential complexes in the area take responsibility for maintaining the public areas adjoining their properties and businesses and convince them that litter reflects badly on them as neighbours and corporate citizens. And something really need to be done to change the attitudes of public transport in the area. Their belief that it is OK to dump food, drinks and cigarette butts at the bus stop is appalling.

I look forward to further comments from Council."

#### Response

"Thank you for your question and bringing this matter to our attention.

This area is scheduled for maintenance twice a week however due to other operational and staffing needs this has not occurred in recent weeks. The schedule to maintain the area twice a week has recommenced and you will notice a significant improvement in the coming weeks.

Council is also working with the Body Corporates and adjoining property owners to ensure they understand their responsibilities in maintaining the amenity of the local area."

#### Brian Sanaghan, West Preston

Darebin ratepayers, in addition to the \$52,000 recently wasted on Coral Ross's political campaign to be MAV president, have now been slugged another \$20,000 by the Greens controlled Darebin Council to support the interests of a political minority.

If the Greens political party had a party flag it would be the multi coloured piece of fabric, representing minority sexual interests, now flying over the Preston Town Hall.

Last year the Darebin branch of the Victorian Greens, led by Councillor McCarthy set out with an orchestrated campaign to seize the government of Darebin City. A measure of their success is that the Mayor of Darebin is a member of the Greens.

Flags are used in wartime by the victors to demonstrate victory and to humiliate the vanquished.

By flying the defacto flag of the Greens over the Preston Town Hall, the Greens on Council have set out to humiliate unsuccessful non Greens candidates, and to rub the faces of those who do not agree with their policies and who didn't vote for them in the dirt, by a transparent display of political triumphalism, which as a former candidate, I find offensive and unacceptable.

Councillor, do you agree that Darebin ratepayers should not be forced to pick up the tab to promote the political policies of the Greens?

Councillor do you agree that there is no place in local government for divisive party politics, yes or no?

#### Response

"Being the closest level of government to the community, Council has an important role to promote human rights and challenge discrimination in all its forms. I imagine many people in our community would find your questions offensive.

This Council has had a long-standing commitment to its LGBTIQ community and has proudly flown the rainbow flag to show its support over several years. The rainbow flag itself has a long and distinguished international history as a symbol of pride, identity and inclusion.

People who identify as LGBTIQ make up more than ten per cent of our community and are twice as likely to experience poor mental health outcomes as a direct result of the stigma, prejudice and discrimination they experience every day.

That's why we have a Sexuality, Sex and Gender Diversity Advisory Committee to ensure we are in touch with the needs and concerns of our LGBTIQ community; and a Sexuality, Sex and Gender Diversity Action Plan.

Within our overall equity and diversity policy framework, it's entirely appropriate that a proportion of our Community Support Fund Grants goes to initiatives that support the goal of making Darebin safer or more inclusive for LGBTIQ people.

This is about supporting the people who live in our community, not party politics."

Mr Sanaghan interjected a number of times throughout Cr. Le Cerf's response. Cr. Le Cerf advised Mr Sanaghan that if he continued to interject, he would be required to leave the Chamber.

#### Cr. Amir also provided the following response to Mr Sanaghan's question

"I did move the motion which was supported unanimously; I'd add that one of the roles of Council is protecting and supporting vulnerable groups which include LGBTIQ people. Flying the rainbow flag makes the LGBTIQ people feel safe because it lets people know that we won't tolerate homophobia. The vote to fly the flag was passed unanimously by the whole Council including people from different parties, it has been a symbol of peace and equality since the 1970s.

It is not the role of Council to placate those that feel threatened by equality, it is not the role of Council to placate people who feel resentful towards people who have been elected.

The \$20,000 is to tackle homophobia and threats to the safety of LGBTIQ people. This is why we need this money: because people like you make Darebin an unsafe place for people like us."

Mr. Sanaghan also interjected during Cr. Amir's response.

#### Serena O'Meley, Reservoir

Prior to asking her question, Ms O'Meley also provided the following statement:

"Before I go on to my question I'd just like to express my support for Council's position on LGBTIQ rights and I think that I speak for a lot of people in the audience.

I am not in the Greens. I am an independent community activist and I think that your behaviour (Mr Sanaghan) is outrageous."

Mr. Sanaghan interjected during Ms O'Meley's response.

Ms O'Meley then asked the following questions:

"Section 46L(1)(a) and (1)(b) of the Planning and Environment Act 1987 (the Act) currently sets a maximum level for Community Infrastructure of \$900 per dwelling to be constructed and in any other case, 0.25 cents in the dollar of the cost of the building work for the development.

(a) Under the previous Developer Contribution Plan, was the full amount of the Community Infrastructure levy set and collected in accordance with the Act, inclusive of any yearly indexation?

#### Response (a):

"For a DCP to achieve Ministerial approval and be incorporated into the Planning Scheme, it needs to be justifiable in terms of its strategic basis (ie. the why) and its composition. This includes that, for example, it must have infrastructure projects identified for the life of the DCP, the infrastructure need must meet the demand, and it must have a reasonable time horizon. Council can't just charge the maximum amount without this justification. The planning scheme amendment process will seek to clarify this through public consultation and before any Independent Planning Panel hearing.

It is worth noting that, for the previous DCP there were 227 charge areas and not all the areas applied the full \$900 rate. This is because, in some cases, there were insufficient projects to justify charging the full rate - in accordance with the Development Contributions Guidelines."

(b) Will Council commit to collecting the full amount allowable for Community Infrastructure under the new DCP?"

#### Response (b):

"Council is currently undertaking work to compile a new DCP which is in accordance with the State Government's 'Development Contributions Guidelines'."

#### Serena O'Meley, Reservoir

"In response to a question which I put to Council on 15 May 2017, the Mayor stated, in part, that, "Council is unable to immediately levy a development contribution without completing a Development Contributions Plan (or an Infrastructure Contributions Plan)."

This contradicts a response which Cr Trent McCarthy posted on my Facebook Wall on 14 May 2017 at 21:26 which he stated was emailed to him by one of the Council Directors:

"Council will seek to complete the DCP as soon as possible, and even prior to its implementation in the planning scheme, officers can look to apply charges to developers - as long as the charges can be justified before the Victorian Civil and Administrative Tribunal, if challenged."

I further note that Cr McCarthy's response to me is consistent with the following section of the Council Resolution (Minute no. 17-175) which was passed on 15 May 2017:

- "(3) Requests officers to commence work on an "Infrastructure Plan and Development Contributions Policy" for identified precincts and activity centres, to be used as an interim measure to charge development contributions prior to the mechanisms being implemented into the Darebin Planning Scheme."
- (a) Can the Mayor explain why her response to my question, presumably on the advice of officers, appears to contradict advice provided to Cr McCarthy as well as part of the formal DCP resolution which determined to develop policy as an interim measure for charging development contributions?
- (b) Based upon information which was emailed to me at the request of the Mayor, was the option of seeking a voluntary agreement from developers via Section 173 of the Act explored and is this the mechanism by which contributions will be collected on an interim basis?"

#### Response

"There is no contradiction of statements. Council has been clear that it is looking to apply a development contribution as soon as possible. Whilst applying the DCP through a planning scheme amendment process into the Planning Scheme is a longer term project, as previously suggested by Councillors, there is an opportunity for Council to prepare and adopt an Infrastructure Contributions Policy, which is clear and transparent, and provides the justification required to apply the infrastructure cost.

Council encourages any member of the public to discuss the requirements of the DCP directly with Council officers."

#### Darren Rudd, Manager Planning and Building also provided the following response:

"The comment "that Council would collect contributions from developers where the charge could be justified in VCAT" was correct. Council is already applying to a limited extent conditions on planning permits requiring contributions or at times full cost of works where the development benefits from these off site works. This ability will be expanded when Council completes a development contributions plan or infrastructure contributions plan because it will have more projects identified and justified to enable more widespread development contributions to be required through legal agreements under Section 173 of the Planning & Environment Act (1987)."

#### Maria Poletti, Dada

At the Council Meeting on April 4<sup>th</sup> 2016 Council carried a motion (Minute No. 158) to endorse Amendment C156 – Request of Ministerial Amendment For Neighbourhood Residential Zone. Amendment C156 which aims to ensure a balanced application of the new residential zones is achieved in the municipality. In short, to increase the Neighbourhood Residential Zone coverage from only 11% in Darebin.

1. Has Amendment C156 been signed off by the Minister and entered into the Darebin Planning Scheme?

2. If not, what is Council doing to expedite the process or has the amendment been shelved?

#### Response

- 1. No. Amendment C156 was refused by the Minister on 5 September 2016.
- 2. On 27 February 2017, Council considered a report on its options available to deliver an appropriate level of protection across the Municipality in light of the refusal of Amendment C156. This has been given priority through budget initiatives for the 2017/2018 financial year.

#### Chris Erlandsen, Preston

- 1. I understand that Council has received endorsement of C137 from the Minister and wondering whether the rescinded amendment that was presented has been changed at all.
- 2. Commensurate with C137 I am wondering if Council is demanding an upgrade to Route 86 particularly between Wood Street and South to the junction where tram get to considerable speed and defects in the track create excessive vibration and noise.

#### Response

"Amendment C137 was gazetted by the Minister last week the 1 June. In response to your additional question about the motion to rescind, I will probably have to take that one on notice and that I take your point around needing to advocate for upgrades to the Route 86 tram. I don't know if that is already taking place or if there is something we should be considering now but again we will follow that one up and get a written response to you."

#### Mandy Baird, Preston

At the Cazaly Ward meeting on 30 May, 2017, Councillor Williams stated that she was not at the Council Meeting on 21 September 2015, where the Rescind motion of Amendment C137 was carried.

1. Does the Councillor wish to change her position to reflect the record in the minutes that she was present at this meeting?

#### Response

- Cr. Williams has indicated that she has already responded to you.
- 2. The minutes of the meeting on 21 September 2017 (page 91) record a division that was called by Cr. Greco at 10.59, with Cr. Walsh, Cr Laurence, Cr. Williams, Cr. Fontana, Cr. Tsitas voting for and Cr. Greco, Cr. Villella and Cr. McCarthy voting against.

How do I access the video footage of this meeting to confirm this division refers to the rescind or an extension of time?

If the video footage is not available, why does the Council not store archived meetings online in perpetuity?

#### Response

For storage reasons we only have three months of the videos up online but I am sure at request they could be made available and we can follow up directly with you about that.

#### John Nugent, Keon Park

"Madam Mayor

Three meetings ago I asked a question (in relation to public toilets). So far I haven't received a reply.

Madam Mayor, can you follow up so I do receive a reply."

#### Response

Cr. Le Cerf advised the question would be taken on notice and followed up.

#### Geoff Richards, Reservoir

"I refer to Storey Reserve, Storey Road. I raised the issue at recent Ward meeting, lighting is bad at the entry, OK hallway, bad halfway along the laneway at far end.

Can spots be located to deal with this, it is winter and dark and the laneway is a used walkway/bike path access to Northernhay Street and beyond for people moving to Reservoir Station and beyond.

Can current budget be reviewed?"

#### Response

"I believe that the budget submission process closes on 8 June so there is still time for you to put in a submission into the budget process so that this particular project gets considered for the budget for the forthcoming year. But it is definitely something that we will take a look at in terms of the issues that you have raised and get back to you about what might be possible for that area."

#### Response to Public Question taken on notice at the Council meeting on 15 May 2017

At the Council meeting held on 15 May 2017, the following question was taken on notice by the Chairperson.

#### • Anne Laver, Northcote

"Will the Council please consider implementing a Parking Overlay for the Market? The development plan for the market indicates that 4888 spaces are required, yet the plans show only 324 parking spaces with from what I understand no visitor parking provided.

The Preston Market fits all the criteria for a Parking Overlay Scheme outlined in the State Government Practice Note 57, April 2013."

## Steve Hamilton, Director City Futures and Assets has provided the following written response to Ms Laver

"Thank you for your questions submitted to public question time at the 15 May 2017 council meeting. The following information is now provided to you.

Parking overlays are most effective in precincts where there are a number of separate land holdings and a base level of consistency is sought. In this instance, with a single large land owner, a parking overlay would have minimal benefit and the development of one would essentially reflect the process being undertaken through the current planning application but without the flexibility to produce a variety of development offerings (i.e. all developments would be locked into the same car parking rate).

Instead, what we are seeking in this instance is a detailed car parking management plan that will address the following:

- Proposed traffic management and control works on site and on adjoining roads.
- Details of how car parking and loading would be managed across all land in the Priority
  Development Zone Schedule 1 (Preston Market) throughout the development stages
  including any proposed parking restrictions, hours of operation and security
  arrangements where relevant.
- How the site will operate, including predicted peak demands, parking restrictions, hours
  of operation, security arrangements, any off-site parking requirements, etc during
  potential interim stages and during construction.
- The overall operation of car parks
- An assessment of car parking demand taken at the completion of each immediately
  prior stage of development or the application. The assessment is to enable car parking
  provision to be monitored as floor areas increase and patronage, travel patterns and
  the mix of uses change, with a view to minimising parking undersupply at any one
  stage of development.

The above details go well beyond what can be incorporated into a parking overlay and allow Council to continue to monitor the operation of the site and adjust parking requirements prior to approving any future stages. We consider this to be the best approach for this precinct."

#### Summary

- Proposal:
  - Construct a four (4) storey building (including one (1) basement level) containing 20 dwellings (8 one (1) bedroom dwellings and 12 two (2) bedroom dwellings), 20 car parking spaces, and 10 bicycle parking spaces.
  - The building has a maximum overall height of 10.156 metres.
  - Private open space to the dwellings is provided in the form of either ground floor courtyards or upper level balconies.
  - A 1.2 metre high fence is proposed above a 1.05 metre (maximum) high raised garden bed at the Gilbert Road edge of the site.
- The site is zoned General Residential Zone Schedule 2
- There is no restrictive covenant on the title for the subject land.
- Six (6) objections were received against this application.
- The proposal is contrary to the relevant policies of the Darebin Planning Scheme.
- It is recommended that the application be refused.

#### Consultation

- Public notice was given via one (1) sign posted on site and letters sent to surrounding owners and occupiers.

7.1 KANGAROOS IN GRESSWELL WILDLIFE RESERVE

#### **Report Background**

This report is in response to Notice of Motion No. 279, resolved by Council on 2 May 2016.

#### **Previous Council Resolution**

'That Council:

- (1) Notes with alarm the recent health issues affecting Kangaroos in Gresswell Wildlife Reserve and the community concern caused by the now abandoned State Government Kangaroo cull. Council therefore resolves to develop a Greater Gresswell Forest land management and Kangaroo and Wildlife protection plan to protect the health and welfare of local Kangaroo populations by strengthening vegetation protections and by putting in place legal protections to preserve in perpetuity the wildlife movements and Kangaroo feeding places within the network of Gresswell Forest-linked parklands that are within the city of Darebin.
- (2) Council notes that these parklands in the Darebin LGA, namely the Gresswell Hill area, the Strathallan Golf course, the Habitat link, the Gresswell Grange Lakes and La Trobe Universities bushland areas, are larger than the current Gresswell Wildlife Reserve and collectively form a vital habitat for Kangaroo populations.
- (3) Officers report back to Council on the feasibility for a health and welfare plan to assist in preserving the Kangaroo population as soon as possible, in consultation with relevant stakeholders.

Furthermore, that this plan for Kangaroo protection in parklands within the City of Darebin include but not be limited to:

- An enhanced tree and vegetation protection schedule across all the parkland areas
- A grassland management plan for Kangaroos and a feed plan for droughts and summer months
- The development and resources for a Friends of Gresswell Kangaroos group
- The removal or redesign of colorbond fences and any current obstructions between these parkland areas
- The creation of safe a wildlife underpass or crossing points for Kangaroos between La Trobe University's bushland and the habitat link
- A wildlife safety report on Main Road and the Ring Road
- The development of a section 173 agreement between La Trobe University and Darebin Council to ensure permanent protection of access to grasslands for Kangaroos on the Habitat Link and the Strathallan golf course.

- Any required updating of current planning zoning and Darebin's MSS to limit land use in line with Darebin's Kangaroo protection plan.
- An outline of a consultation plan with Springthorpe Owners Corporation, Strathallan Golf Club and La Trobe University and relevant animal Welfare and rescue groups.
- Options for sourcing state government funds to support the proposed local kangaroo protection plan.'

#### **Previous Briefing(s)**

This matter has not previously been to a Councillor Briefing.

#### **Council Plan Goal/Endorsed Strategy**

- Goal 3 Sustainable and Resilient Neighbourhoods
  - 3.7 Biodiversity, Wildlife corridors, cultural heritage assets and waterways

#### **Summary**

Gresswell Forest, Gresswell Hill, the Habitat Link, Strathallan Golf Course and Latrobe Universities Wildlife Reserve are all important flora and fauna reserves. These reserves are managed by Parks Victoria and Latrobe University and are within Darebin boundaries.

Within some of these reserves are wild populations of kangaroos. These populations naturally fluctuate, increasing when conditions are suitable and falling in drought and other adverse conditions. When in excess the health of the population can be impacted through starvation or spread of disease. Both Parks Victoria and Latrobe University currently monitor Kangaroo populations and when required provide assistance to injured wildlife. These are wild populations naturally foraging for food. This natural foraging is important to maintain the natural instincts of the population, supplemental feeding may lead to them become tame and pose a greater threat to their health and safety.

Council currently manages Reserves within close proximity and these reserves are managed for the floristic diversity with the aims to bolster native populations of indigenous plant species and control and where possible eliminate a suite of weeds. This vegetation is the natural food source for Kangaroos and if numbers continue to rise this will create an imbalance leading to a deterioration in natural vegetation and animal welfare.

Currently the major risk to the Kangaroos is increasing population. Parks Victoria have implemented a fertility program and its aim is to have a sustainable population within 10 years. The road network that segregates the Reserves could present issues to the safety of kangaroos in the area but over the last few years very few incidents involving Kangaroos and vehicles have been recorded. Council will continue to monitor the situation and install warning signs for motorists to raise awareness of possible kangaroo's crossing.

As the kangaroos are wild populations and their management is controlled by government legislation and regulation the introduction of a health and welfare plan by Darebin is not feasible.
