5.2 PUBLIC APOLOGY TO MIDSUMMA FESTIVAL, DARDI

MUNWURRO AND DAAC

Take notice that at the Special Council Meeting to be held on 12 February 2024, it is my intention to move:

That Council:

- (1) Notes the email from the Midsumma Festival and forwarded to all Councillors on 19/01/2024.
- (2) Notes the letter from Dardi Munwurro to all Councillors emailed on 19/01/2024.
- (3) Notes the email received by the Darebin Aboriginal Advisory Committee (DAAC) on 18/01/2024.
- (4) Directs the Mayor to write to the Midsumma Festival, Dardi Munwurro, and the Darebin Aboriginal Advisory Committee (DAAC) on behalf of Council apologising for:
 - a) Lack of consultation regarding the removal of the Palestinian flag.
 - b) Not "gain(ing) permission" to use their names in justifying Council's previous (now rescinded) motion to remove the Palestinian flag.
 - c) Causing "great distress".
 - d) Being "used and weaponised" to remove the Palestinian flag.

Rationale

Council recently received correspondence from the Midsumma Festival, Dardi Munwurro and the Darebin Aboriginal Advisory Committee (DAAC). The letters and emails raised serious concerns about how these organisations and community members have been inappropriately referenced in council's decision-making processes without their knowledge or consent.

Given the "great distress" felt by these respected parties, Council should urgently provide a public apology via a motion of Council to acknowledge their legitimate concerns.

5.3 PUBLIC TRANSPARENCY OF COUNCIL DECISIONS

Take notice that at the Special Council Meeting to be held on 12 February 2024, it is my intention to move:

That Council:

- (1) Notes that section 58 of the Local Government Act states that the "Council decision making processes must be transparent" except if dealing with information that is confidential.
- (2) Notes Darebin's Public Transparency Policy that council has "committed to being accountable to the community through transparency" and "may decide, in the interests of transparency, to release information to the public, if it is in the public's interest" and when the decision is no longer required to be confidential.
- (3) Makes publicly available MINUTE NO. 23-005 of the confidential section of the 25 January 2023 council meeting in relation to the decision of the Bill Lawry Oval Pavilion that was going to cost \$12.9mil to complete, while withholding any details which may be commercially confidential.
- (4) Makes publicly available Item 5.1 "Action arising from the VCAT decision on Northcote Plaza from the 6 June 2022 council meeting", which withholding any details which may be commercially confidential.
- (5) Makes publicly available all decisions regarding the Alphington Rail Spur from any council meeting during this term, while withholding any details which may be commercially confidential.
- (6) Makes publicly available all decisions regarding the Melbourne Innovation Centre at 2 Wingrove Street Alphington, from any council meeting this term, while withholding any details which may be commercially confidential.

Rationale:

5.4 NORTHCOTE AQUATIC AND RECREATION CENTRE

Councillor: Susan RENNIE

NoM No.: 28/2023

Take notice that at the Special Council Meeting to be held on 12 February 2024, it is my intention to move:

That Council notes:

(1) Notes:

- a. The redevelopment of the Northcote Aquatic and Recreation Centre was completed by Darebin Council on time and on budget with expenditure of \$63.5 million.
- b. Darebin Council delivered and funded this project including through borrowings of \$49M in total from the Victorian Government of which \$10 million is a low interest Community Sports Infrastructure loan.
- c. At the official opening of the facility, the Minister for Community Sport spoke of Council's \$53 million investment in the facility.
- d. In the state government media release following the opening, the Member for Northcote Kat Theophanous said "The Victorian Government is giving communities the facilities they need so more locals can boost their health and participate in the activities they love."
- e. These comments understate Council's investment and overstate the State Government's contribution to the redevelopment of NARC as the State Government had no role in the planning, design and construction of the redevelopment, and made no financial contribution other than via a low interest loan and a Changing Places grant to the value circa \$26K.
- f. Despite minimal investment in the facility, the State Government Community Sports Infrastructure Acknowledgement and Publicity Guidelines stipulated that the Minister was entitled to open the facility and be named in first place on the plaque.

And

That Council:

- (2) Resolves to write to the Minister and the local member and invite the State Government to convert the loan to a grant so that the above statements are true and accurate representations to our community of the funding and commitment to the redevelopment of the NARC.
- (3) In the event that the loan is transitioned to a grant, refers consideration of using the entirety of the sum on the redevelopment of Bill Lawry Oval pavilion redevelopment project to the 24/25 Council Plan and Budget development process.
- (4) Requests that officers prepare a brief report for Council consideration at the earliest possible opportunity on criteria that Council can use going forward to consider applying for and accepting grants including acknowledgement and publicity guidelines.
- (5) Formally thanks all council staff and contractors who contributed to the delivery of the NARC project on time and on budget.
