4.1 DRAFT ANNUAL BUDGET 2020–21 AND DRAFT STRATEGIC RESOURCE PLAN 2020–24 RELEASE FOR COMMUNITY CONSULTATION

The annual budget is an essential planning and resource tool produced each year. The development of a considered budget is vital to the ongoing operational and financial viability of Council. The budget sets out the expected income and expenditure for operational, strategic and capital activities for the coming year and also incorporates Council's rating strategies. The 2020/21 budget is informed by Council's ten year capital works plan.

For 2020/21, the Councils annual budget has been significantly influnced by and directed towards Councils response to the COVID-19 global pandemic. Council's projected income has been dramatically impacted and services directly affected.

In responding these unprecedented times, it is critical that Council maintains a sound financial position so that Council can support both the community and achieve financial obligations now but also in the medium and long term.

On 27 March 2020, Council took a significant position to support our community impacted by coronavirus, introducing a raft of initiatives to support residents, community organisations and local businesses. This includes the adoption of a COVID-19 Financial Hardship Policy and the endorsement of the COVID-19 Community and Local Business Resilience and Recovery Package.

Council's \$11.3 million package complements the existing Federal and State Government recovery and stimulus packages and focuses on the most vulnerable in our community. Importantly, the total value of Councils efforts to support the community is significantly higher when in kind support via staff redeployments and service redirections are taken into account. This effort is made more significant when considering that Councils own financial circumstances have also been impacted with an estimated reduction in revenue of at least \$15 million expected.

This budget should be read together with the Community and Local Business Resilience and Recovery Package and the Financial Hardship initiatives adopted by Council.

The budget documentation forms part of a comprehensive public accountability process and reporting that includes:

- The Council Plan
- The Strategic Resource Plan
- The Annual Budget
- Internal and external audit
- The Annual Report

The draft budget contains the information specified in the *Local Government Act 1989* ('the Act') and all details required by the Local Government (Planning and Reporting) Regulations 2014 ('the Regulations'). It has also been prepared in accordance with the model budget template.
