## Re: Darebin City Council – Wood Heater Odour Log

I refer to your recent request relating to odour/smoke from a wood heater that is causing you concern. Wood heaters are a legal form of heating that when used correctly should not create emission, please note smoke may be visible up to 20 minutes after lighting or loading a wood heater.

If you are concerned about air pollution from a wood heater the Environment Protection Authority (EPA) is the primary regulator. Darebin's Health Protection Unit is responsible for investigating residential wood heaters where wood smoke emissions may be creating a public health risk. For information on the types of odour/smoke that Council investigate, please see <u>Council's website</u>.

Do you wish to:

- □ Report wood heater emissions affecting air quality. Report to EPA air pollution hotline on 1300 372 842.
- □ Report wood heater emissions that are affecting your health. Progress to complete the attached log.

To assist our Officer's in investigating the allegation of nuisance we request you complete a wood heater log, this log has been enclosed for your action. The log must be completed for at least a <u>14-day</u> period as this allows Council to identify any patterns regarding frequency, duration, and outline where the odour/smoke is entering your home including bedroom, lounge room, etc. We seek your support in this investigation, please complete these logs with accuracy and include clear descriptions because they may be used as evidence if further action is pursued.

The data provided will enable an Authorised Officer to determine whether the odour/smoke is potentially unreasonable or may be deemed a nuisance that requires further investigation. In order to be considered a nuisance, the emission needs to be affecting your health. The officer is required to detect the emission from within a habitable room of your dwelling when the wood heater was operational to confirm it is dangerous to health.

Enforcement action can only be taken if a nuisance is found to exist as required by under the Public Health and Wellbeing Act 2008.

# Complaints in relation to the compliance of wood heater installation, building structure or plumbing issues are not investigated by the Health Protection Unit.

Where an odour/smoke emission is not deemed to be unreasonable or a nuisance, Council will not be able to take any further action. In these cases, you will be advised to speak to your neighbour directly, consider mediation with your neighbour through the Dispute Settlement Centre of Victoria or seek to resolve the matter privately.

Where odour logs have not been returned to Council after a period of 30 days from the
