### **How to Complete a Barking Dog Diary**

Your accuracy in recording the nuisance barking is of extreme importance as it may be presented as evidence in Court.

Please create a detailed diary **over a 10 day period** as the example indicated below and attach the diary to the Barking Dog Complaint Form.

Completed form **must** be returned to Council within 7 days of the last date recorded or Council cannot take action and another diary set will need to be completed.
