

5.1 DAREBIN COMMITMENT TO PEACE

EXECUTIVE SUMMARY

Darebin City Council has a long-standing commitment to promoting peace and harmony and has played a leadership role with respect to social justice and inclusion for the local and broader community.

Council engages with diverse faith leaders and its broader community to promote social cohesion and celebration of diversity. Council recognises that its community is increasingly distressed by the growing unrest and division in Australia and around the world as most recently displayed through the hateful attack at Bondi.

Council has an opportunity to maintain its strong and visible commitment to peace in a way that reduces misinterpretation and ambiguity by adopting the Peace Flag as a symbol that applies universally.

Officer Recommendation

That Council affirms its commitment to peace in Australia and across the world and replaces the Palestinian Flag to enable the Peace Flag to be flown at Preston City Hall.

KEY INFORMATION

Darebin City Council has a long-standing commitment to promoting peace, harmony and social justice. Council is committed to serving and responding to the diverse needs of the community and as outlined in its *Towards Equality* framework strives to consider the principles of equity, diversity, inclusion and human rights in everything it does.

Council engages with diverse faith leaders through the Darebin Interfaith Council and other forums and invites its community to celebrate diversity through a range of community events and its Intercultural Centre.

Darebin is an official supporter of the ICAN Cities Appeal, formally endorsing the UN Treaty on the Prohibition of Nuclear Weapons. The Council has also committed to an Investment & Treasury Policy that preferences financial institutions that do not fund the arms industry.

In December 2023 Council decided to raise the Palestinian Flag as a gesture of solidarity with the people of Palestine and all those affected by the conflict, in Darebin and beyond. There have been a variety of views in the community about the ongoing flying of this flag and the recent attack on the Australian Jewish community in Bondi has led to confusion about what the flag symbolises.

Council has affirmed its commitment to peace and non-violence in a joint statement following the incident in Bondi, stating it stands against all forms of hatred and discrimination. This was also clear in Council's resolution at its meeting in September 2025 where it reaffirmed its commitment to equity, diversity and inclusion in Darebin and condemned the aggression and hostility shown at the attack on Camp Sovereignty.

Council has an opportunity to maintain its strong and visible commitment to peace in a way that reduces misinterpretation and ambiguity by adopting the Peace Flag as a symbol that applies universally.

Legal and Risk Implications

The recommendation to Council is within its legal authority. From a governance perspective, if Council supports this recommendation, and resolves to replace the Palestinian Flag with the Peace Flag, it satisfies the requirements of the previous decision in December 2023 that a resolution is required to cease flying the Palestinian Flag.

This recommendation supports the wellbeing and safety of community members, Councillors and staff as it demonstrates a calm and inclusive action in a time where there is growing unrest and division.

IMPLEMENTATION ACTIONS

If Council supports this recommendation the Palestinian Flag will be removed from the community flagpole at Preston City Hall and replaced by the Peace Flag.

Council has already advised the community that it will consider adoption of a Flag Policy in the first half of 2026. Council has the opportunity to consider ongoing display of the Peace Flag at that time.
