Domestic Animals Act

All domestic animal businesses are required to register their premises under the Domestic Animals Act 1994, failure to do so is an offence under section 45 of this Act. Domestic Animal Business means:

- (a) an animal shelter, Council pound or pet shop; or
- (b) an enterprise that is run for profit which carries out all or any of the following activities—
 - (i) the breeding of dogs or cats, where—
 - (A) the enterprise has more than 3 fertile female animals of either or both species; or
 - (B) the enterprise has less than 3 fertile female animals but the owner is not a member of an applicable organisation; or
 - (ii) the rearing, training or boarding of dogs or cats

This personal information is used by Council and may be disclosed to the Government Departments in connection with the administration and enforcement of the above mentioned Act, but will not be disclosed to anyone else unless required to by law.
